M.R.029550 - In re: Kiflom Tekie Meles. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent Kiflom Tekie Meles, who has been disciplined in the District of Columbia, is disbarred in the State of Illinois.

Motion by the Administrator of the Attorney Registration and Disciplinary Commission to approve and confirm the report and recommendation of the Hearing Board. Allowed. Respondent Bianca Christina Lee is disbarred.

Motion by the Administrator of the Attorney Registration and Disciplinary Commission to approve and confirm the report and recommendation of the Hearing Board. Allowed. Respondent Colin Francis Carr is suspended from the practice of law for three (3) months and until further order of the Court.

M.R.029565 - In re: Jeffrey Wade Deer. Disciplinary Commission.

Motion by the Administrator of the Attorney Registration and Disciplinary Commission to approve and confirm the report and recommendation of the Hearing Board. Allowed. Respondent Jeffrey Wade Deer is suspended from the practice of law for fifteen (15) months.

Suspension effective February 19, 2019.

Respondent Jeffrey Wade Deer shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.

M.R.029566 - In re: Brian M. Fornek. Disciplinary Commission.

Motion by Brian M. Fornek to strike his name from the roll of attorneys licensed to practice law in Illinois pursuant to Supreme Court Rule 762(a). Allowed. Effective immediately.

M.R.029569 - In re: Ralph Frederick Tellefsen, III. Disciplinary Commission.

Motion by Ralph Frederick Tellefsen, III to strike his name from the roll of attorneys licensed to practice law in Illinois pursuant to Supreme Court Rule 762(a). Allowed. Effective immediately.

M.R.029574 - In re: Tyrone Davis. Disciplinary Commission.

Motion by the Administrator of the Attorney Registration and Disciplinary Commission to approve and confirm the report and recommendation of the Hearing Board. Allowed. Respondent Tyrone Davis is suspended from the practice of law for three (3) years and until further order of the Court and until he pays restitution in the amount of \$750 to Ressie Holmes; \$1,500 to Beth Griffin; and \$1,090 to Derrick Plummer and Gwenevere Plummer Scales.

M.R.029576 - In re: Michael Glen Conrad. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission for leave to file exceptions to the report and recommendation of the Review Board. Denied. Respondent Michael Glen Conrad is suspended from the practice of law for six (6) months, with the suspension stayed in its entirety by a one (1) year period of probation, subject to the following conditions:

- a. Respondent shall comply with the provisions of Article VII of the Illinois Supreme Court Rules on Admission and Discipline of Attorneys and the Illinois Rules of Professional Conduct and shall timely cooperate with the Administrator in providing information regarding any investigations relating to his conduct;
- b. Respondent shall reimburse the Commission for the costs of this proceeding as defined in Supreme Court Rule 773 and shall reimburse the Commission for any further costs incurred during the period of probation;
- c. At least thirty (30) days prior to the termination of the period of probation, respondent shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct;
- d. Probation shall be revoked if respondent is found to have violated any of the terms of probation. The remaining six (6) month period of suspension shall commence from the date of the determination that any term of probation has been violated;
- e. Respondent shall notify the Administrator within seven (7) days of any arrest or charge alleging his violation of any criminal or quasi-criminal statute or ordinance;
- f. Respondent shall attend meetings as scheduled by the Commission probation officer;
- g. Respondent shall submit to an independent audit of his client trust account, conducted by an auditor approved by the Administrator, at respondent's expense, six (6) months after the commencement of probation. Respondent and the Administrator shall each receive copies of the audit;
- h. Respondent shall notify the Administrator within fourteen (14) days of any change of address;

- i. Respondent shall successfully complete the ARDC Professionalism Seminar within the first six (6) months of probation;
- j. Respondent shall establish and utilize a system for the handling of funds belonging to clients and third parties that conform to the requirements of Rule 1.15 of the Illinois Rules of Professional Conduct (2010) and instructions provided to respondent by the Administrator, including the following Trust Account Procedures:

Basic accounting records that must be maintained daily and accurately:

Account Check Register – list sequentially all trust account deposits and trust account checks and maintain a current and accurate daily balance on the trust account;

Account Receipts Journal – list chronologically all deposits into the trust account, each deposit to list the date of the deposit, the source of each deposit, the client matter, the deposit number and the amount of the deposit, and maintain a copy of each item deposited;

Account Disbursement Journal – list chronologically all trust account disbursements and identify each disbursement with the date of the disbursement check, the trust account check number, the payee, the purpose of the disbursement, the client matter, and the amount of the disbursement check;

Client Ledger Journal – list chronologically for each client matter all receipts, disbursements and remaining balances, preparing a separate page for each client matter and listing chronologically all receipts and disbursements and remaining balances for each client matter; and

Source documents which must be preserved for seven (7) years;

Bank statements;

Deposit slips;

Cancelled checks – all trust account checks must have a named payee (no checks written to "cash") and the memo portion of the check must contain a reference to a client matter;

Time and billing records;

Copies of records from client files that are necessary for a full understanding of the lawyer's financial transactions with the client: e.g., retainer and engagement agreements; settlement statements to clients showing the disbursement of the settlement proceeds; bills sent to clients and records of payments to other lawyers or non-employees for services rendered; and

Reconciliation – there must be a running balance maintained for all ledgers and account books. The balances in the client ledger journal must be reconciled each month with the balances in the trust receipts and disbursement journals, the account checkbook register and the bank statements. Records of each reconciliation must be maintained for seven (7) years;

- k. Respondent shall disclose to the Administrator on a quarterly basis, by way of signed reports, information pertaining to the nature of respondent's compliance with the above-described conditions;
- l. Respondent shall promptly report to the Administrator any failure to comply with any part of the above-described conditions; and

m. Respondent shall respond to any inquiries by the Administrator regarding respondent's compliance with the above-described conditions.

M.R.029588 - In re: Robert Vincent Schaller. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose discipline on consent pursuant to Supreme Court Rule 762(b). Allowed. Respondent Robert Vincent Schaller is suspended from the practice of law for six (6) months.

Suspension effective February 19, 2019.

Respondent Robert Vincent Schaller shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.
