**JUSTICE RITA B. GARMAN TO ADMINISTER OATH TO NEW  
ATTORNEYS**

Illinois Supreme Court Justice Rita B. Garman will preside, and administer the attorney's oath when 88 new lawyers are admitted to practice in ceremonies in Springfield on Thursday, November 8.

The group is among 2,351 men and women who were certified as candidates and will be sworn in as Illinois attorneys at ceremonies in the state's five Supreme Court judicial districts.

The Springfield program in the Fourth Judicial District will begin at 10 a.m. in the Michael J. Howlett Building, located at the intersection of Second and Jackson Streets in Springfield.

Justice Garman will welcome the members of the class, their families and friends.

Other guests of the Illinois Supreme Court will be: Chief Circuit Judges Tracy Resch from the Fifth Circuit, John Shonkwiler from the Sixth Circuit, James Day from the Seventh Circuit and Thomas Brownfield from the Eighth Circuit; Associate Judge Thomas M. Harris, Jr. from the 11<sup>th</sup> Circuit; Raylene DeWitte Grischow from the Central Illinois Women's Bar Association; and Jack C. Carey, president-elect of the Illinois State Bar Association.

The Honorable Ronald D. Spears, circuit judge from the Seventh Judicial Circuit, will serve as keynote speaker for the ceremony.

Quincy attorney Charles A. Scholz will make the motion to admit the class.

Attorneys Frederic W. Nessler from Springfield and Brian A. Braun from Monticello will both second the motion to admit the class.

A reception will follow.

All of the candidates have passed the Illinois State Bar Examination and an ethics examination; and were certified by the Committee on Character and Fitness.

The new attorneys will bring the total number of licensed attorneys in Illinois to approximately 84,000.
